Re: Sal Squatrito Legislative Award Nomination – 2026**

**It is my honor and pleasure to nominate Senator Anwar for the Sal Squatrito Legislative Award for 2026.**

**Senator Anwar has been a long-standing and steadfast advocate for oral health initiatives in the State of Connecticut. In his role as Chairman of the Connecticut General Assembly's Public Health Committee, he has consistently demonstrated leadership in advancing public safety and improving access to care for Connecticut residents. Senator Anwar clearly understands the critical connection between oral health and overall health, and throughout his tenure he has provided thoughtful guidance and direction in shaping effective, evidence-based legislation.**

**Under Senator Anwar's leadership, Connecticut became the only state in the nation to preserve community water fluoridation through statute. Codifying fluoride levels in Connecticut law—rather than relying solely on federally determined standards—was a strategic and visionary legislative action that ensured long-term protection of this vital public health measure. This achievement is especially notable given the highly competitive legislative session in which more than 4,000 bills were introduced, with only 313 ultimately enacted.**

**In addition to this landmark accomplishment, Senator Anwar successfully shepherded four new laws supporting oral health care initiatives through the legislative process, further demonstrating his commitment to improving the health and well-being of Connecticut's citizens.**



**For his unwavering advocacy, informed leadership, and meaningful legislative impact on oral health policy, I respectfully urge the committee to give Senator Anwar your strongest consideration for the Sal Squatrito Legislative Award.**

My Name is David Fried, and I am announcing my candidacy for Delegate to the American Dental Association in 2025. I am currently representing CT and District 1 on the ADA Council for Dental Practice (CDP). I currently serve on the ADA Workforce subcommittee. In 2023-2024, I chaired the Practice and Policy subcommittee from the Council on Dental Practice. In 2021-2022, I represented that committee on the National Eldercare Advisory Committee (NECAC), and Dental Wellness Advisory Committee (DWAC). I serve as the liaison from the Council to the Dental Assistance National Board (DANB). During the ADA House of Delegates in 2021, I was asked to serve as the Chairman of the Committee on Rules and Order (CRO), a huge honor for me and for Connecticut. I am currently the Co-Chair of the CSDA Council on Government Relations.

I am a Past-President of the Connecticut State Dental Association, and have been a delegate or alternate for 8 years previously. I have forged strong relationships with leadership throughout the ADA Board, District 1 and across the country. In 2018, I was selected to serve as a member of the Reference Committee dealing with Insurance benefits, practice and related matters. I chaired the same reference committee at the New England District 1 Caucus. It was an eye-opening experience, which I feel gives me a unique benefit to serve our delegation, and to lead round-table discussions. I have served on many councils and committees at the CSDA, and am a volunteer clinical instructor at UCONN.

As Chair of Policy and Practice sub-committee for the ADA Council on Dental Practice, my committee spearheaded two very important policies that will change our practices. The first deals with workforce. We are looking at development of new training models and trying to invigorate the influx of assistants and hygienists into the workforce. As we look at this National problem, we realize that the solution is to develop local projects to immediately give relief to business owners. The other issue we are centering our focus on is the growing problem of sustainability. The amount of non-recyclable materials is creating mountains of refuse. The costs associated with packaging and infection control have spun out-of-control. My committee was charged with developing policies to change the direction of the pressures on Dental practices. Currently, the structure of this project has created a multi-council approach to problem solving, and I am a member of this important project.

Under my tenure as Co-Chair of the CSDA Council on Government Affairs, the CSDA has made incredible progress in the Legislature and Regulatory world. Our committee has been advocating for the Medical Loss Ratio (MLR), Joint Contract Negotiations (JCN), Fillers, Anesthesia, Medicaid, and other insurance reform
