Dear Ms. Gerrity and Members of the House of Delegates,

It is with deep gratitude for our Association, optimism for its future, and a profound sense of responsibility to our profession that I submit this letter of intent to run for President-Elect of the Connecticut State Dental Association.

Serving the CSDA has been one of the most meaningful and formative experiences of my professional career. Through progressive leadership roles at the local, state, and national levels—and most recently through my service as Vice President—I have gained a comprehensive understanding of the challenges facing organized dentistry, as well as the extraordinary opportunity we have to shape the future of our profession in Connecticut. I seek the office of President-Elect with a commitment to continuity, collaboration, and forward-looking leadership grounded in service to our members and the patients we care for.

As Vice President, I have worked closely with the President, President-Elect, Board of Governors, and CSDA staff to advance the Association's mission through strategic planning, sound governance, and member-focused initiatives. These experiences have reinforced for me that effective leadership is not about any single individual, but about building alignment, maintaining institutional strength, and preparing the organization for long-term success. The President-Elect role is uniquely positioned to do just that—by honoring the work already underway while helping to chart a thoughtful and ambitious path forward.

One of the accomplishments of which I am most proud to see come to fruition during my time in CSDA leadership is our Association's advocacy work to protect and preserve community water fluoridation in Connecticut. Through coordinated legislative advocacy, coalition-building, and the sustained efforts of CSDA members and leaders, Connecticut became the first state in the nation to enact state law that explicitly preserves community water fluoridation. This achievement represents far more than a policy win; it is a clear demonstration of what organized dentistry can accomplish when we speak with one unified voice on behalf of evidence-based public health, disease prevention, and health equity. As a dentist with formal public health education, I view this milestone as both a validation of our advocacy efforts and a foundation upon which future public health and legislative initiatives can be built.

My professional background as a practicing general dentist, hospital-based attending, and public health-educated clinician shapes my leadership philosophy. Daily clinical practice keeps me grounded in the realities our members face: rising costs, stagnant and sometimes decreasing reimbursement rates, workforce issues, student debt, regulatory complexity, and the ongoing challenge of delivering high-quality care in an evolving healthcare landscape. At the

same time, my public health training reinforces my belief that strong professional advocacy and organized leadership are essential to improving oral health outcomes statewide. These perspectives guide my approach to leadership—practical, data-informed, inclusive, and always focused on both measurable member success and the public good.

Throughout my service with the CSDA, I have had the privilege of serving on and contributing to numerous councils, committees, and delegations, including Strategic Planning, Governmental Affairs, Membership, Audit, and the Connecticut Delegation to the ADA HOD. I currently serve as both Vice President and Chair/Action Team Leader (ATL) Coordinator for the Connecticut Delegation to ADA Dentist and Student Lobby Day, where I work closely with our members and elected officials to advocate for dentistry at the federal level. These roles have provided me with a working knowledge of the Association's governance, finances, legislative priorities, and operational structure—experience that is critical for effective service in the presidential track.

If elected President-Elect, one of my primary areas of focus will be growing and retaining CSDA membership, with particular attention to new dentists and early-career practitioners. As a new dentist myself, I understand firsthand the questions, financial considerations, and career pressures that influence engagement with organized dentistry. Membership growth is not solely about recruitment; it is about relevance, value, and connection. The CSDA must find ways to maintain its relevancy with both new dentists facing numerous new practice modalities, and seasoned dentists who are looking at how to navigate an ever-changing dental landscape. We must prove our value to both our members and the public as *the* trusted voice of dentistry in the State of Connecticut. And we must do this all by connecting, in-person, online, and every way in-between with our members, potential-members, and the community at large.

To that end, I am committed to advancing several concrete initiatives. Firstly, the establishment of a structured and meaningful mentorship pipeline that intentionally connects dental students, new dentists, and early-career practitioners with experienced members who wish to give back to the profession. In addition, I support the creation of a formal, state-level New Dentist Committee to elevate early-career voices within CSDA governance, identify emerging issues, develop targeted programming, and cultivate future leaders. These initiatives directly support improved membership retention, measurable engagement across career stages, and a sustainable leadership succession model that continuously develops new leaders. In doing so, we ensure that responsibility is shared broadly across a prepared and willing volunteer base, rather than overburdening the same dedicated individuals, allowing the CSDA to grow its leadership capacity and remain resilient well into the future.

Second, I am committed to offering comprehensive onboarding and leadership training for council, committee, and component society leaders. Providing clear orientation, governance education, and leadership development at the outset empowers volunteers to be effective quickly, enhances consistency across the Association, and demonstrates that the CSDA values and invests in those who choose to serve. We must prepare our leaders to both understand the foundational ways in which to effectively run their organization/meetings, including proper use of AIP Standard Code of Parliamentary Procedure, and also how to integrate and safely use a

widely emerging landscape of artificial intelligence tools to make their work more efficient and succinct, while maintaining professional integrity.

Finally, I will work diligently to modernize CSDA operations to enhance the member experience while maintaining fiscal prudence. As expectations for accessibility, efficiency, and transparency continue to evolve, the CSDA must ensure that its internal operations, technology, and processes reflect the needs of a modern professional association. This includes thoughtful investments in systems that improve communication, streamlined governance and volunteer workflows, and enhancing the overall member experience, while remaining disciplined stewards of Association resources. Strategic modernization—guided by data, member feedback, and long-term financial planning—will allow the CSDA to operate more efficiently, deliver greater value to members, and position the Association for sustainable growth without compromising fiscal responsibility.

In addition to membership growth, I am committed to advancing advocacy and leadership development across all career stages. The CSDA has established itself as a local, state and national leader in advocacy, and we must continue to build on that momentum. This includes equipping our members with the tools and confidence to engage in legislative advocacy, fostering relationships with policymakers, and maintaining Connecticut's strong presence at every level of government. Our success in preserving community water fluoridation is a model for what sustained, strategic advocacy can achieve, and it should inspire continued investment in this critical work. Additionally, I am committed to working collaboratively with CSDA staff, the Board of Governors, component societies, and future leaders to ensure that the Association remains strong, adaptable, and responsive to the evolving needs of our members.

I am hopeful about the future of dentistry in Connecticut and optimistic about the role the CSDA will continue to play in shaping that future. We are strongest when we lead with integrity, engage inclusively, and advocate boldly for our profession and our patients. If elected President-Elect, I pledge to bring energy, transparency, and a deep sense of stewardship to this role, while preparing diligently for the responsibilities of the presidency. Together, we will ensure that the Connecticut State Dental Association is and will always remain *the* trusted voice for the profession of dentistry in our great state.
