

Delegates and Alternates to the Connecticut State Dental Association House of Delegates:

As a long term and quite active member of the Connecticut State Dental Association, I am entering my name for candidacy of President-Elect of the Connecticut State Dental Association.

Our great profession of dentistry has been and continues to be faced with some critical issues in the upcoming legislative session, the outcome of which has the potential to change the very way dentistry is practiced in Connecticut.

My primary focus for our Association is advocacy. I was quite concerned when the CSDA took the position to advocate and testify for Substitute Bill #7303, Public Act 19-72 which creates dental therapists in Connecticut, was passed by the state legislature 18 June 2019 and signed into law by Governor Lamont 8 July 2019. Not discussing nor communicating this with component leadership in our state for input is of great concern to me. This action now directly affects the manner with which dentistry will be practiced in our state and most directly affects those who are in the beginning stages of their careers.

I have been quite active on the legislative front, having been elected to the Town Council in Southington for three consecutive terms or six years. During that time, I have still been active within the Connecticut State Dental Association as President of the Dental Society of Greater Southington. Also within that time, the Dental Society of Greater Southington has had a legislative night each year, with the majority of those representing Southington (and in election years, their opponents) attending the evening. I reached out to these individuals themselves! I maintain a constituent relationship with these individuals and am able to reach out to them on pertinent matters. At a Dental Society of Greater Southington meeting, I distributed to members in attendance a list of methods to reach out to legislators on behalf of dental issues before our state legislature. In addition, I have attended Dental Day at the Capitol on a yearly basis.

There has also been a steady decline in membership of the CSDA and retired/life membership is on the rise. This will affect the voice of our profession in the state, as well as having a fiscal impact on our Association. New vibrant members are the key to the future of our Association. It is vital that their voices be heard and that proactive ideas and processes be incorporated into the workings of the CSDA. This can only be done with new, fresh voices that are, in the end, the future of our Association. By encouraging membership and not only membership, but an active participatory membership in the CSDA, can our organization survive and thrive.

Communication is also the key to active membership. Reaching out to non-members, students, members and leaders on all levels is key to recruitment and retention. By keeping the grass roots members apprised of goings on within the organization, the CSDA remains vital. Communication must be done not only through email and snail mail, but through the old-fashioned phone call, the newer fashioned text and just through saying "Hi" at a meeting or seminar. That's how one gets another involved. Several individuals whom I have in the past appointed to Councils and Committees have gone on to leadership positions within the CSDA. Some of those are continuing to serve on CSDA Councils and Committees. By personal contact was this done. Having individual members who are highly engaged in the CSDA will keep the CSDA a member driven organization and not become a staff driven organization. It is this hands-on approach that engages our grass roots members to become involved in their profession and in the organization that states that it is the voice for oral health care in Connecticut.
